

# **Clinical Policy: Nirogacestat (Ogsiveo)**

## Description

Nirogacestat (Ogsiveo<sup>TM</sup>) is a gamma secretase inhibitor.

## FDA Approved Indication(s)

Ogsiveo is indicated for adult patients with progressing desmoid tumors who require systemic treatment.

## **Policy/Criteria**

*Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.* 

It is the policy of health plans affiliated with Centene Corporation<sup>®</sup> that Ogsiveo is **medically necessary** when the following criteria are met:

## I. Initial Approval Criteria

- A. Desmoid Tumor (must meet all):
  - 1. Diagnosis of a desmoid tumor (aggressive fibromatosis);
  - 2. Prescribed by or in consultation with an oncologist;
  - 3. Age  $\geq$  18 years;
  - 4. Documentation of a progressing desmoid tumor;
  - 5. For Ogsiveo requests, member must use nirogacestat, if available, unless contraindicated or clinically significant adverse effects are experienced;
  - 6. Request meets one of the following (a or b):\*
    - a. Dose does not exceed 300 mg (6 tablets) per day;
    - b. Dose is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).
       \*Prescribed regimen must be FDA-approved or recommended by NCCN

## Approval duration: 6 months

## **B.** Other diagnoses/indications (must meet 1 or 2):

- 1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
  - a. For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.33 for health insurance marketplace, and CP.PMN.255 for Medicaid; or



- b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.103 for health insurance marketplace, and CP.PMN.16 for Medicaid; or
- 2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid.

## **II.** Continued Therapy

## A. Desmoid Tumor (must meet all):

- 1. Currently receiving medication via Centene benefit, or documentation supports that member is currently receiving Ogsiveo for a covered indication and has received this medication for at least 30 days;
- 2. Member is responding positively to therapy;
- 3. For Ogsiveo requests, member must use nirogacestat, if available, unless contraindicated or clinically significant adverse effects are experienced;
- 4. If request is for a dose increase, request meets one of the following (a or b):\*
  - a. New dose does not exceed 300 mg (6 tablets) per day;
  - b. New dose is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).
    \*Prescribed regimen must be FDA-approved or recommended by NCCN

## Approval duration: 12 months

## **B.** Other diagnoses/indications (must meet 1 or 2):

- 1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
  - For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.33 for health insurance marketplace, and CP.PMN.255 for Medicaid; or
  - b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.103 for health insurance marketplace, and CP.PMN.16 for Medicaid; or
- 2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid.

## **III. Diagnoses/Indications for which coverage is NOT authorized:**

A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies –



CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid or evidence of coverage documents.
